# Doctor rape-murder 'barbarity expressed in extremity': V-P

**VICE PRESIDENT** Jagdeep Dhankhar on Sunday termed the violence committed against a "health warrior" at Kolkata's RG Kar Hospital on August 9 as "barbarity expressed in extremity".

Addressing students and faculty members at AIIMS Rishikesh, Dhankhar said such barbaric incidents put the entire civilisation to shame and shreds what Bharat stands for.

Lamenting the use of the term 'symptomatic malaise' by some stray voices, Dhankhar said such statements "aggravate

"When it comes from someone who is a Member of Parliament, a senior advocate, then the culpability is of an extreme degree. There can be no al-
